Texas Government Code Sections:


- 551.071 For the purpose of a private consultation with the board's attorney on all subjects or matter authorized by law.
 - 1. When the governmental body seeks the advice of its attorney about:
 - A) pending or contemplated litigation; or
 - B) a settlement offer; or
 - 2. On a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with this chapter
 - 3. Consider legal advice regarding items specifically listed on the Agenda
- 551.072 For the purpose of discussing the purchase, exchange, lease, or value of real property.
- 551.073 For the purpose of discussing negotiated contracts for prospective gifts or donations
- 551.074 For the purpose of considering the appointment, employment, resignation, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee.
 - 1. Consider hiring of professional and non-professional personnel
 - 2. Consider renewals, non-renewals and terminations of contracts for professional personnel
 - 3. Conduct the summative annual evaluation of the Superintendent of Schools and consider action on approval/extension of said contract
- 551.076 For the purpose of considering the deployment, specific occasions for, or implementation of, security personnel or devices
- 551.082 For the purpose of considering discipline of a public school child, or complaint or charge against personnel
- 551.0821 For the purpose of considering a matter regarding a public school student where personally identifiable information about the student will necessarily be revealed by the deliberation
- 551.083 For the purpose of considering the standards, guidelines, terms, or conditions the board will follow, or will instruct its representatives to follow, in consultation with representatives of employee groups
- 551.084 Excluding witnesses from a hearing

- B. Consider approval/extension of Superintendent's said contract.
