

| 551.072  | For the purpose of discussing the purchase, exchange, lease, or value of real property.   |
| 551.073  | For the purpose of discussing negotiated contracts for prospective gifts or donations   |
| 551.074  | For the purpose of considering the appointment, employment, resignation, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee. <ol style="list-style-type: none"><li>1. Consider hiring of professional and non-professional personnel</li><li>2. Consider renewals, non-renewals and terminations of contracts for professional personnel</li></ol>   |
| 551.076  | For the purpose of considering the deployment, specific occasions for, or implementation of, security personnel or devices  |
| 551.082  | For the purpose of considering discipline of a public school child, or complaint or charge against personnel  |
| 551.0821 | For the purpose of considering a matter regarding a public school student where personally identifiable information about the student will necessarily be revealed by the deliberation  |
| 551.083  | For the purpose of considering the standards, guidelines, terms, or conditions the board will follow, or will instruct its representatives to follow, in consultation with representatives of employee groups   |
| 551.084  | Excluding witnesses from a hearing  |
