- For the purpose of considering discipline of a public school child, or complaint or charge against personnel
- For the purpose of considering a matter regarding a public school student where personally identifiable information about the student will necessarily be revealed by the deliberation

  For the purpose of considering the standards, guidelines, terms, or conditions the board will follow, or will instruct its representatives to follow, in consultation with representatives or
  - follow, or will instruct its representatives to follow, in consultation with representatives of employee groups
